A. Emerging digital customer protection requirement

Mr Jonathon Thorpe, Deputy Chief Executive Officer, Services Australia provided members with a
summary of the Employment Services Framework and Section 47C
Consultations were taking place with agencies to identify protections
that would be useful, including accessibility measures, and with the DTA on the Digital Service Standard. Section 34
. Further work on a digital protections framework is not
considered valuable as legislation is already in place, albeit across a multitude of acts, for most
elements. No further actions are proposed at this stage.
Members noted the work undertaken to consult across the Australian Public Service (APS) on
opportunities for a whole of government approach to digital protection requirements in the updated
Digital Service Standard, and the exploration of an APS-wide Customer Experience Standard via the APS
Reform agenda. Further, members noted that work has already progressed, with the inclusion of digital
protection requirements in the updated Digital Service Standard via the APS Reform agenda and that Section 47C
Finally, members noted the approach will be reviewed in late 2024 to consider if
further mechanisms are required to ensure a consistent approach to digital protections across the APS.

B. Update on Digital & ICT planning project

Co-Chair Griggs introduced this item noting the rework of the paper for SDDC consideration and highlighting the working group allocation against recommended actions in Attachment C. Members discussed the recommendations to enhance the quality of planning to support digital investment decision-making included in the paper circulated.

The ATO requested to participate in working group 7 (Develop a consistent approach to sustainment funding and maintaining digital assets) and Services Australia requested to join working group 5 (Consider options for dedicated investment funds for design, pilots and prototypes).

Members agreed the need to progress work on the recommendations quickly and for timeframes to be added to each recommended action.

Members **agreed** the prioritised recommendations of the Long-term Digital Investment Planning Report at page one of **Attachment A** and **agreed** to small working groups progressing implementation design and reporting back to SDDC **Attachment C**.
