CONSULTATION: RELEASE OF INVESTMENT INFORMATION TO PARLIAMENT OF AUSTRALIA

Late last year, the Hon Paul Fletcher MP tabled questions in writing ([available on the Parliament of Australia website](#)) to the Minister representing the Minister for Finance. These questions are seeking specific information relating to digital and ICT projects being delivered across the Australian Government which are subject to central oversight by the Digital Transformation Agency under the [Digital and ICT Investment Oversight Framework](#).

The DTA is now preparing a response to these questions and is seeking your agency's comment on information which has been identified as in-scope for release.

In your response, you have an opportunity to:

- Clarify or update the information held by the DTA to ensure an accurate and helpful response is provided in response to the questions.
- Identify where your agency intends to claim immunity for the production of any of the identified information on the grounds that public disclosure would be prejudicial to the public interest.

A response from your agency using the enclosed template is required by email to portfolio.assurance@dta.gov.au by no later than COB on 22 January 2024. This timeframe is not flexible – the maximum possible time has been allowed for agencies to respond to this request while meeting strict Ministerial clearance and Parliamentary tabling deadlines.

Can we also please request that you notify your agency media/strategic communications team of the expected release of information? Closer to the tabling date, we will reach out with additional supporting information for you to share with these teams.
